Faculty Development related to Teaching

Participation in faculty development activities focused on improving teaching skills is required to maintain a faculty appointment at the Virginia Tech Carilion School of Medicine. Similar to skills in clinical medicine, interprofessionalism, biomedical science, or research, the skills for teaching at a medical school/research institute can always be improved. Faculty members are required to participate in at least 6 hours of FDT during the 3-year maintenance of appointment cycle (2 hours per year). Faculty unable to demonstrate participation in these activities will be in jeopardy of losing the appointment.

What options are available?

Opportunities for completing **FDT** are available through a variety of options both within as well as outside our organization. Please see the table below for guidelines and documentation instructions. As always, feel free to contact the Office of Faculty Affairs or Faculty Development for additional questions or concerns.

As a reminder: Attendance at typical CME or CEU sessions is not necessarily considered **FDT unless the session specifically relates to the development of a participant's skills as a teacher.** However, many FDT sessions offer CME or CEU hours.

*If there is a session offered within your program or department that you believe **SHOULD** count toward the FDT hour requirement **for a group of individuals**, please contact Mariah Rudd (mjrudd@carilionclinic.org) for pre-approval to advertise and/or share with your faculty using this distinction.*

What Counts toward FDT?

Other specialized activities that count:

- Participation in the Health professions Education Research (HERS) program
- Attendance at faculty development teaching sessions offered through the Center for Simulation, Research, and Patient Safety
- Participation in the VTCSOM Department of Admissions sessions on diversity (**1-hour per year, per cycle**)
- Attendance at teaching/educational development sessions offered by other educational institutions in the region including Radford University at Carilion, Virginia Tech, and others (with pre-approval)
- Participation in professional teaching development activities offered through professional organizations (e.g., medical or nursing societies, education programs) as part of regional or national meetings
- Attendance at national education or teaching focused conference (examples include: ACGME, AAMC, SGEA, CORD, CREOG, APGO)

This does NOT count

- Participation in events related to the development of your skills as a clinician or researcher (unless specifically related to education research).
- Reviewing specific journal articles related to improving your skills as clinician, researcher or anything not related to teaching.
- Developing/presenting educational content to develop the skills of others as clinicians, researchers, or anything **not related to teaching**.
- Reading books/book chapters or journal articles **not related to teaching or education**.
- Reading non-CME approved journal articles related to teaching or education.

Additional information

- **Faculty professional development in teaching** activities DO NOT need to be CME-approved.
